

RESOLUTION NO. 2026-56

ADOPTED AUGUST 19, 2026

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CALISTOGA, COUNTY OF NAPA, CALIFORNIA, APPOINTING THE NOMINEES TO THE OFFICE OF CITY COUNCIL AND CANCELING THE CITY'S GENERAL MUNICIPAL ELECTION SCHEDULED FOR TUESDAY, NOVEMBER 3, 2026, PURSUANT TO ELECTIONS CODE SECTION 10229

WHEREAS, on May 12, 2026 the City Council adopted Resolution No. 2026-30 calling for the holding of a General Municipal Election on Tuesday, November 3, 2026, for the election of Mayor and two City Councilmembers as required by the provisions of the laws of the State of California relating to General Law cities; and

WHEREAS, the Notice of Election was published on July 2, 2026; and

WHEREAS, the nomination period was open from July 13, 2026, to August 7, 2026, and the extended nomination period was open from August 7, 2026, to August 12, 2026; and at the close of the extended nomination period only one candidate per City Council seat was nominated; and

WHEREAS, a Notice of No More Candidates Than Offices to Be Elected was posted pursuant to law on August 13, 2026, and the City Clerk certified to the City Council that there were not more candidates than offices to be elected for the offices of Mayor and Councilmember; and

WHEREAS, pursuant to California Elections Code Section 10229, since, at the close of the extended nomination period on August 12, 2026, there were no more candidates than offices to be elected for the offices of Mayor and Councilmember, the City Council can take one of the following actions:

1. Appoint to the office the person who has been nominated.
2. Appoint to the office any eligible voter if no one has been nominated.
3. Hold the election if either no one or only one person was nominated.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CALISTOGA AS FOLLOWS:

SECTION 1. Pursuant to Elections Code Section 10229(a)(1), the following persons are appointed to the Office of Mayor and 2 Councilmember Offices:

For the Office of Mayor – Kevin Eisenberg
For the Office of Councilmember – Scott Cooper
For the Office of Councilmember – Lana Richardson

SECTION 2. The General Municipal Election scheduled for November 3, 2026 is hereby canceled.

SECTION 3. The persons appointed shall qualify and take office and serve exactly as if elected at a municipal election for the office.

SECTION 4. The City Clerk shall certify to the adoption of this resolution and shall cause the same to be processed in the manner required by law.

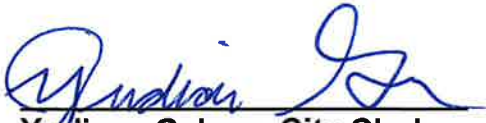

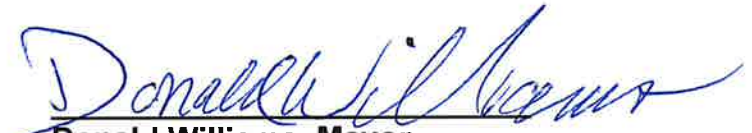
