CONTACT PERSON: It is the responsibility of the User to distribute recycled water in a way that assures compliance at all times with current regulations. In order to accomplish this, the User shall designate, with the approval of the City of Calistoga, a Recycled Water Supervisor to provide liaison with the Recycled Water Program. This person may represent the owner as appropriate, however, he/she must be responsible for the recycled water distribution and available at all times, with authority to carry out any requirements of the Recycled Water Program.

THIS PERMIT MUST BE AVAILABLE FOR INSPECTION AT ALL TIMES: The recycled water distributor must keep a copy with the tanker truck and be prepared to present it to the City of Calistoga personnel for water pick-ups. The user/distributor must adhere to General Water Reuse Order No. 96-011 and CCR Title 22 to ensure proper use of the recycled water.

DAMAGE TO FACILITIES: The User shall pay for all damage to City-owned property caused by the User, its agents, employees, or invitees.

INDEMNIFICATION: User shall hold harmless, defend and indemnify City of Calistoga its officers, officials, employees and volunteers from and against all claims, damages, losses and expenses including attorney fees which actually or allegedly arise out of its participation in the City of Calistoga Recycled Water Program, caused in whole or in part by any negligent act or omission of the User, any subcontractor, anyone directly or indirectly employed by any of them or anyone for whose acts any of them may be liable, except where caused by the active negligence, sole negligence, or willful misconduct of City of Calistoga its officers, officials, employees and volunteers.

CERTIFICATION: I hereby certify under penalty of perjury that the information provided in this permit and any attachments is true and accurate to the best of my knowledge. The permit is subject to all prohibitions, specifications, and provisions of General Water Reuse Order No. 96-011.

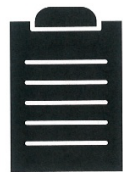
